

## **Job Description: Executive Director**

**Location:** Saskatoon or Regina, Saskatchewan (Office provided on First Nations reserve land in either city; some remote work is acceptable)

**Overview:** The Executive Director (ED) serves as the operational and strategic leader of the Indigenous Manufacturing & Contracting Network (IMCN), Canada's first Indigenous-led, manufacturing and contracting cluster. Reporting to the Board of Directors and working closely with the Board Chair, the ED will strengthen IMCN's established systems, enhance its impact, and manage daily operations. The ideal candidate will bring strong business acumen in budgeting, financial management, task prioritization, and legal compliance to ensure IMCN's sustainable growth and member support.

**About IMCN:** At IMCN, we empower Indigenous communities to foster collaborative thinking to further drive workplace innovation. Our purpose is to improve the quality of life of Indigenous people and generate long-term prosperity through the support and promotion of Indigenous business and individuals in the manufacturing and contracting sectors.

## **Key Responsibilities:**
